

## PETITE PAWS PLAYCARE OWNER AGREEMENT

I,	, hereby certify that my
dog(s):	is/are up to date on all required vaccinations (Rabies,
Bordetella and DHPP). I further	certify that my dog(s) has/have not harmed or shown
aggressive threatening behavior t	towards any persons or any other dog. I have read and
understand the following.	

I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending playcare or dog walking at/with Petite Paws Playcare Ltd. ("the company").

- 1. I further understand and agree that the Company and their staff will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation with the Company.
- 2. I further understand and agree that dogs can sometimes receive minor cuts and scratches and any problems that develop with my dog(s) will be treated as deemed best by staff of the Company, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
- 3. I agree to allow Petite Paws personnel to walk my dog and assume full liability for any issues that may arise while outside the facility.
- 4. The Owner agrees that the dog(s) may be videotaped, photographed, and/or recorded while at the Company and that these files may be used in the future for promotional purposes.
- 5. The Owner understands and agrees that the pet(s) is/are required to be picked up by 6:30pm and that late pick ups may be subject to a \$30 surcharge.
- 6. The Owner understands that any dog accepted who is not spayed/neutered may be subject to risk from other dogs, and agrees to spay/neuter or remove the dog from daycare until surgery is completed when the dog reaches 8 months of age.
- 7. The Owner agrees to not bring their unspayed female dog to daycare when they are in heat or pregnant.

- 8. The Owner agrees to ensure the dog is in good health coming into daycare, and has not been ill with a contagious disease in the last 30 days and the Company reserves the right to deny entry/send home to injured or sick dogs.
- 9. The Owner agrees that a daycare environment is not suitable for all dogs and that Petite Paws Playcare reserves the right to terminate attendance at any time for reasons such as (but not limited to):
  - a. Excessive barking
  - b. Aggressive/intolerant behavior towards staff or other dogs
  - c. Excessive mounting and/or marking
  - d. Incompatibility with play group
  - e. Showing signs of fear or stress
- 10. The Owner

I certify that I have read and understand the policies and conditions of the company as set forth in the preceding paragraphs. In consideration of, and as inducement to the acceptance of my application, I hereby agree to indemnify and hold harmless PETITE PAWS PLAYCARE, its officers, directors, instructors, agents, employees, and/or representatives of any and all claims, or claims by any member of my family, of injury, expense, costs or damages to my dog or any handler sponsored by me. In addition, I agree that I will defend and indemnify the Company for any injury, expense, costs or damages to any dog handler or dogs, whether sponsored by me or not, or to third parties arising out of my own actions or the actions of my dog. I have read the above-stated provisions, and agree to accept those responsibilities.
